The Program Change in Master of Social Work to delete a prerequisite was approved unanimously by the committee.

ARC 5328, and ARC 5352 were unanimously approved by the committee pending a change to the most current form from the August 2003, to the September 2012.

The Program changes in Nursing- Master of Science in Nursing(All tracks) deleting a letter of recommendation, termination of the BSN/MS Degree Program, were unanimously approved by the committee.

The Program change Nurse Educator Track to consolidate the three courses by terminating NGR 6940, NGR 6946, NGR 6947 and adding changes to NGR 6944L,were unanimously approved by the committee.

The program change to EEC 6711 in Education to change title and description and was unanimously approved by the committee.

Program Change- PhD with Major in Ocean Engineering, BS/MS program in Mechanical Engineering, BS/MS in Ocean Engineering, and PhD with Major in Mechanical Engineering were unanimously approved by the committee.

EEL 5613 was unanimously approved by the committee pending changes to the first page of the syllabi. There was to be a correction to the incorrect course number and effective date. There should also be a memo from the College of Science that there is no conflict of interest.

The Program Change in the Graduate Programs Catalogue Description in Arts and Letter was unanimously approved by the committee.

The three memos in Business to add concentrations in existing master's degree programs -Proposal for Tax Concentration in the SOA Master of Accounting Program, Proposal for an Accounting Information System Concentration in the SOA Master of Accounting, and Proposal for Business Valuation Concentration in the SOA Executive Master of Accounting program were grouped together and approved unanimously by the committee.
The MBA Curriculum change was unanimously approved.

ACG 5691, ACG 5693, ACG 5694, ACG 5866, ACG 6685, ACG 6868, were grouped together and approved unanimously approved. Pending addition of effective dates, and clarification to the syllabi on ACG 5691 and ACG 6685 regarding grading that should be made clearer for the students.

ACG 6373, ACG 6374, and ACG 6377 were grouped together and unanimously passed with effective date of Summer 2013.

ACG 6625 was unanimously approved by the committee.

ACG 6685 was unanimously approved by the committee pending changes to effective date Fall 2013 with a change to grading scale.

BUL 6455 was unanimously approved by the committee.

The College of Medicine materials were submitted at such a late time that the committee didn't have enough time to look over. The changes that they did see would be resubmitted on Thursday to the College of Science, and the College of Nursing who are the reviewers. When they approved, the material would then be sent to the GPC Committee and the GC Committee. It would then be voted on at the GC meeting on March 27, 2013.

The meeting was adjourned at 3:30pm.
