Course Description:

This course will provide examination and discussion of counseling and supervision issues affecting speech language pathologists and the discipline of communication disorders. Theories of supervision and counseling will be explored, giving students the opportunity to discuss clinical experiences in each area.

Learner Outcomes:

Demonstration of these learner outcomes will be determined by a passing performance on exams, class discussions, and written assignments. Upon completion of this course, students will be able to:

- 1. Discuss the components of the supervisory process and the supervisory continuum.
- 2. Discuss various styles of supervision and when each might be appropriate.
- 3. Utilize a variety of data collection systems to observe the supervision process.
- 4. Develop a plan for self-supervision.
- 5. Identify methods of counseling within the speech-language pathology scope of practice, with focus on listening and assisting clients in dealing with challenges related to communication disorders.
- 6. Implement counseling strategies with clients of all ages and their significant others.

Textbook Requirements:
