## MYTH AND THE BIBLE (LIT 6408, 3 credits)

**COURSE DESCRIPTION**: This course will explore the role and significance of mythology, focusing on ancient Near Eastern traditions and their relationship to the Old Testament, particularly the early chapters of Genesis.

**COURSE OBJECTIVES**: Students will become familiar with common themes in ancient Near Eastern mythological literature and their reflexes, including similarities and differences, in the Bible.

**PREQREQUISITES**: graduate standing

**REQUIRED READINGS**: Students are expected to have read the assigned material <u>prior</u> to the class session at which it is to be discussed and to bring a Bible (any translation is acceptable) to each meeting. In addition to the Bible, the following required texts are available in the University bookstore:

Stephanie Dalley, *Myths from Mesopotamia* (Oxford University Press, 1989) Simon Parker, *Ugaritic Narrative Poetry* (Society of Biblical Literature, 1997) Robert Segal, *Myth: A Very Short Introduction* (Oxford University Press, 2004)

Other required readings, which are noted in the assignments below, can be found in William Hallo, *The Context of Scripture* ("Hallo") or James Pritchard, *Ancient Near Eastern Texts Relating to the Old Testament* ("Pritchard"), both which are available at the University library, or on the course's Blackboard website as marked with asterisks on the course outline below.

There will be two written assignments, each of which will constitute 40% of your grade. The first, which should be approximately ten double-spaced pages long, is to be an overview, describing how one modern scholar understands myths. Possible subjects include Mircea Eliade, James Frazier, S.H. Hooke, Carl Jung, Claude Lévi-Strauss, Bronislaw Malinowski, and Edward B. Tylor. The papers are due on February 18.

The second paper should be a research project of approximately 25 double-spaced pages on any relevant topic of your choosing. A written proposal, listing the topic and a preliminary bibliography, is due in class on January 21. The paper itself is due on April 15; a rough draft may be turned in by March 18 for initial feedback. Grades for papers that are turned in late will be lowered 5%. A brief (10 minute) synopsis of your findings will be presented orally during the "Final Exam" time slot on April 29.

The remaining 20% will be based on attendance, with 5% taken off for the second and each subsequent absence.
