FAU Course Catalog Description:

Phonetics (LIN 6226) 3 credits Graduate introduction to phonetics. Articulation and transmission of speech sounds, connected speech processes, transcription, and acoustic measurements. Collection and analysis of phonetic data.

Course description:

This course is a comprehensive introduction to the field of *phonetics*, which is the discipline that investigates the production of sounds during speech. We will examine how speech sounds are articulated and transmitted through the air, how sounds are measured and transcribed, which types of sounds are found in different languages, and how neighboring sounds affect each other during speech. We will also collect and analyze phonetic data.

Course goals:

The goals of the course include:

- discussing foundational phonetic concepts;
- collecting and analyzing phonetic data;
- conducting acoustic analyses;
- practicing transcription of speech sounds using the International Phonetic Alphabet.

Course organization:

This course meets for 15 weeks and during the finals week (see the Calendar). We will read and discuss journal articles & book chapters covering a wide range of topics in phonetics. We will also collect and analyze phonetic data and practice transcription. Readings will be announced in-class and on Canvas one week in advance and will need to be done prior to coming to class. will also (i) do a brief in-class presentation of 1 journal article/book chapter from a list of supplementary readings, (ii) complete 4 homework assignments, (iii) complete 3 laboratory assignments. There will be no written in-class tests or exams in this course.

Presentation of a supplementary reading:

Each student will read and present one journal article/book chapter from a list of supplementary readings. The list of readings, relevant dates, and instructions for the content of the presentation and the grading criteria will be announced in class and posted on Canvas. Sign up will be done on a first-come, first-serve basis.

Assignments:

There will be 4 homework assignments and 3 laboratory assignments during the semester (see the Calendar for tentative dates). Both types of assignments will involve collection and/or analysis of phonetic data and phonetic transcription. Instructions for completing the assignments will be announced in class and posted on Canvas one week before they are due. Assignments submitted after the deadline but no more than 48 hours late will not receive a score above 87% (B+). No credit will be given for any assignment submitted more than 48 hours late. Extensions will only be granted in the case of a documented medical emergency (supporting documentation will be required) or for university-approved reasons (e.g., participation in an FAU-sponsored sporting event). Technology failures are not a valid excuse for not submitting the assignments. (Technological assistance is available via the FAU Help Desk: <https://helpdesk.fau.edu/>).

Attendance, participation & communication devices:

You are expected to come to class prepared, having read the required materials (as announced in class), and fully ready to participate in all in-class discussions and activities. Graduate students are expected to attend every single class. If you must miss class for circumstances beyond your control, you will be responsible for contacting your classmates to obtain any missed information. FAU's Handbook of Academic Policies and Regulations says the following regarding class attendance and communication devices:

Attendance

Students are expected to attend all of their scheduled University classes and to satisfy all academic objectives as outlined by the instructor. For all components of the final grade, scores will be calculated as percentages. There will be **no rounding of grades** beyond the automatic rounding done by Canvas.
