Course Objectives/Student Learning Outcomes

- 1. Write efficient code for solving complex statistical problems.
- 2. Understand and explain core principles of data visualization and apply best practices for selecting appropriate visualization types based on the structure and type of data.
- 3. Develop simulations to generate random variables from various distributions and apply them to estimate statistical properties.
- 4. Apply optimization algorithms (e.g., gradient descent, Newton-Raphson) to fit statistical models and solve optimization problems in maximum likelihood estimation or Bayesian inference.

Time Commitment Per Credit Hour

Equivalent time and effort are required for Summer Semesters, which usually have a shortened timeframe. Grade Appeal Process

Policy on Make-up Tests, Late work, and Incompletes

Any student missing a quiz or exam without an official excuse will receive a zero grade. Any excusable absence must be documented by a verifiable source, and the instructor should be notified AT LEAST ONE WEEK prior to the exam date. If a student misses an exam due to an emergency, such as a car accident or illness, the instructor must be notified WITHIN 24 HOURS after the exam, and written verifiable documentation is required. Students will not be penalized for absences due to participation in University-approved activities provided they notify their instructor and make appropriate arrangements well in advance of the quiz or exam. Similarly, reasonable accommodations will be made for students participating in a religious observance. A make-up must be completed within two weeks of the exam date, except in extraordinary circumstances.

Policy on the Recording of Lectures

Students enrolled in this course may record video or audio of class lectures for their own personal educational use. A class lecture is defined as a formal or methodical oral presentation as part of a university course intended to present information or teach students about a particular subject. Artificial Intelligence Preamble
