






Non-Degree Certificate in School Counseling PK-12

Rationale: There is currently a shortage of school counselors across Florida school districts. The State of Florida has two paths for school counseling certification. <https://www.fldoe.org/teaching/certification/certificate-subjects/administrative-rules/6a-4-0181.stml>

- Plan one requires completing a master's or higher degree in School Counseling.
- Plan two allows individuals with a closely related counseling degree to complete a specified school counseling curriculum, including a 600-hour internship in a K12 setting.
- Applicants using Plan Two shall submit verification from the employing school district to attest that a school counselor with a state-issued professional certificate as specified in Rule 6A-4.004, F.A.C., will be assigned as the applicant's mentor during the first two (2) years of employment as a school counselor.

Florida school districts and individuals request a path for qualified candidates to meet state accreditation requirements without pursuing a degree. The department's School Counseling Concentration aims to create an 18-credit non-degree Certificate in School Counseling PK-12 and address the shortages across Florida. The new certificate includes courses currently provided and does not incur additional program or department costs.

Non-Degree Certificate in School Counseling PK-12 Admission Requirements

1. Earned a master's or higher degree from a CACREP-approved counseling program.
2. Minimum graduate program GPA of 3.0 on a 4.0 scale.
3. A professional goal statement (one-to-two pages).
4. Three letters of recommendation on each reference's letterhead attesting to the student's suitability for graduate study and entry into the field of professional counseling.
5. License as a Clinical Mental Health, Marriage and Family, or Rehabilitation counselor.
6. Verified employment in a Florida school district with confirmation of the applicant's assigned two-year mentor.
