In the most recent Standards for Quality Nurse Practitioner Education (NTF Standards, 2022), the number of direct care clinical hours required for nurse practitioner students has increased to a minimum of 750 hours. Although the 750 hours is not yet required for students to sit for national certification, as schools are implementing this change, it will become the standard for certification.						
The current MSN program of study for the Adult-Gerontological and Family Nurse Practitioner concentrations requires 600 direct care clinical hours and the plans of study for the two concentrations are the same until the last semester of study.						
In order to meet the new 750 minimum hour critieria the proposal is to add 3 credits of clinical practicum to the curriculum, which increases the total credit hours from 49 to 52 for both concentrations of study. This will be accomplished by extending the clinical hours required for NGR6200L from 3 credits to 5 credits. For this course (NGR 6200L) 3 credits (180 direct care clinical hours) will be taken in the spring semester and 2 credits (120 direct care clinical hours) will be taken the following summer. The syllabus for this course will reflect the required direct care clinical hours for each semester. In addition, NGR 6605L which is taught in the following fall will increase from 3 credits to 4 credits to reflect 240 direct care clinical hours.

CURRICULUM PLANS FOR MASTER OF SCIENCE IN NURSING CONCENTRATIONS

Adult/Gerontological Nurse Practitioner - 49 52 credits

Provides graduates with the advanced skills and knowledge to assume the role of Adult/Gerontological Primary Care Nurse Practitioner with an emphasis on responding to calls from adolescents, adults and older adults. The unique features of this program are that it is inclusive of care to culturally diverse adolescents, adults and older adults.

The Adult/Gerontological Nurse Practitioner curriculum requires a total of 4952 credits. The program generally follows a part-time format of study. The curriculum contains a minimum of 600780 hours of required clinical practice. Attainment of competencies may require more than 600780 hours. Placements may occur in health department clinics, private practice offices, home-health agencies, community-based health centers, hospitals, long-term care institutions and other settings providing health care to adolescents, adults and older adults.

Graduates of the Adult/Gerontological Primary Care Nurse Practitioner program are eligible to sit for the Certification Examination offered by the American Nurses Credentialing Center (ANCC) or the American Academy of Nurse Practitioners (AANP).

Family Nurse Practitioner - 4952 credits

Provides graduates with advanced practice role preparation, knowledge and skills in the care of children and adults across all ages within a family framework. Health promotion, disease prevention and management of common acute and chronic long-term health alterations in primary care settings are the foci of this concentration.

The Family Nurse Practitioner curriculum requires 4952 credits. The program generally follows a part-time format of study. The curriculum contains a minimum of 600780 hours of required clinical practice, most of which may be arranged by the student in her or his own community. Attainment of competencies may require more than 600780 hours. Practicum experiences occur in health department clinics, private practice offices, HMO clinics, community-based health centers, hospital clinics and other settings providing primary health care.

Graduates of the Family Nurse Practitioner program are eligible to sit for the Family Nurse Practitioner Certification Examination offered by the American Nurses Credentialing Center (ANCC) or the American Academy of Nurse Practitioners (AANP).
