Why Interdisciplinary Environmental Studies?

The field is flourishing internationally, with new programs appearing almost weekly. The justification for Environmental Humanities, and the intersecting study of Environment and Society, is powerfully made by cultural critic Imre Szeman (University of Waterloo, Minister of Environment) and anthropologist Dominic Boyer (Rice University): “our energy and environmental dilemmas are fundamentally problems of ethics, habits, values, institutions, beliefs, and power—all areas of expertise of the humanities and humanistic social sciences” (2014).

Why Interdisciplinary Environmental Studies at FAU?

The university, aligned with the belated national consensus regarding climate science and the climate emergency, has designated several relevant disciplinary areas as part of its strategic “pillars” and “platforms” for its 2015-2025 strategic plan. These include: Environmental Science, a “Healthy and Environmentally Sustainable Campus,” and “Peace, Justice, and Human Rights.” The last has been channeled into a Certificate program for the Center for Peace, Justice, and Human Rights as well as the Undergraduate Minor in Environment and Society that we passed in Spring 2024 and which will already be awarded to four students in Fall 2024. The graduate certificate would allow for students in our M.A. and Ph.D. programs to pursue a similar course of study. Toward that end, one M.F.A. student and one Ph.D. student have already completed the requirements for this proposed certificate.

It also ought to be noted that a certificate in Environmental Studies had been created many years ago; perhaps because of the institutional climate, or inability to promote the program at the time, the certificate was not adequately supported and thus not successful. Given our ongoing collaborations within and across departments and disciplines—as is evidenced by the successful creation of our new minor, not to mention that all four of our new hires in the Department of English

(unsurprisingly) include Environmental Humanities work in their scholarly pursuits and pedagogical practices—it is clear that this is the right time to get this certificate back on the books.

The strategic plan also stresses relevance and marketability: this course of study is, without question, amongst the most popular and marketable fields of study both nationally and internationally. Questions around energy consumption, and the “greening” of the “energy” sector, are surely central to any discussion pertaining to the nation’s economic (and political) well-being. Consequently, students are virtually guaranteed employment in, for example, Environmental Consulting, Climate Change Mitigation, and the (exponentially increasing) academic discipline of Environmental Humanities.

Not only do the available courses for next year (2024-2025) also speak to the viability of pursuing this field, it is also worth noting that I was approached by a representative from the National Academy of the Sciences—an engineer explicitly seeking a humanist—who is keen on FAU becoming an affiliate institution for the National Gulf Scholars Program, which seeks to cultivate new leaders in areas related to climate, energy, and sustainability. We are now at work on the application. (My colleagues at Rice are affiliate members as well, and we hope to cultivate a more concrete disciplinary and institutional relationship with them.)

Beyond FAU, as an Environmental Humanist and Environmental Justice worker, I work with a core group of international faculty (<https://www.petrocultures.com>) on similar programming; and several members of the Petrocultures community have constructed such degrees, which have been wildly successful. Quite a few of their students have also expressed interest in FAU’s Ph.D. program in Comparative Studies owing to the possibility of pursuing such interdisciplinary work.

Of course, as an Environmental Humanist in South Florida, which many have deemed “ground zero” for the climate crisis in the United States, I also feel that it is a moral imperative to bolster study in areas related to planetary habitability.

Are there peer institutions working on similar degrees?

There are many peer institutions working on similar degree and/or certificate programs: Michigan State University, UC Davis, the University of Oregon, University of Utah, Arizona State University, and many more—too many to list here. Notably, institutions like the University of Oregon and the University of Delaware (a very famous program) fall within the category of aspirational peer as we become an R1 institution in line with FAU100 as well as FAU’s strategic plan, both of which mandate that we work toward institutional inclusion in the nation’s top 100 public schools.

Are there models for academic scholarship that stress interdisciplinarity in a way that would benefit faculty teaching in this area and thus also serve FAU100 in terms of bolstering our research profile?

Amongst the many scholarly collectives within the academy, the Petrocultures Research Group and the After Oil school have been particularly successful in terms of publication on top university presses, securing funding for conference programs and residencies, and mentoring graduate students in the field. As an example, we boast two (soon to be three!) collaboratively authored Environmental

Humanities/Environmental Studies volumes (published on top university presses—e.g., <https://www.upress.umn.edu/book-division/books/solarities>); and I have received several queries from international students regarding such an emphasis for study at the B.A., M.A., and Ph.D. level. It is perhaps also relevant that my own edited anthology, *Oil Fictions: World Literature and our Contemporary Petrosphere*, which is an interdisciplinary Energy Humanities project, has just received its 8th review in a top interdisciplinary journal; and scholarly series like WVU Press's "Energy and Society" along with similarly focused series at MIT, Fordham, Princeton, Duke, and Minnesota, are popping up everywhere.

Apologies for the late response. Why are we limiting this to students already in our graduate programs? Often, certificates can be fulfilled by non-degree seeking students. There might be an audience out there for such students---who are already working in these fields (or hoping to), but who want some kind of "certificate" to make them more marketable. I'm not sure why we would want to restrict those who want to fulfill the certificate.

Also, I do think we're going to be better off if we are only listing courses that are in the catalog. (Many grad courses tend to have variable titles. As long as the prefix/number you list is still in use, I think it's fine. But if there are courses listed that are completely absent from the catalog, I don't think we should include them in the list. If there are new courses to be added, we could try to put them through the committees at the same time.)

Also...I can lend my support as Interim Chair of LLCL if you want/need it. LLCL supports the certificate.
