Course Description (Catalog):

Combines administrative history with analysis of concrete situations in public administration. Portrays clash of forces, personalities, and issues in attempting solution to administrative problems. Typically taken in last or next to last semester. M.P.A. core course.

Course Description (Expanded):

This capstone is designed to give you the opportunity to synthesize, integrate, and apply the knowledge you acquired from the MPA program through active and reflective learning. You will achieve that goal by observing government entities, analyzing real-world public sector challenges, and self-reflection.

We begin the semester by examining citizenship, which includes personal and professional interactions with your city's commission/council. We then delve into governance and public service values. From that point, we focus on leadership of public organizations and services. Each week we closely examine critical and current issues in public administration: ethics, collaboration, public service motivation, and workforce planning. As we explore all of these topics, you will have the opportunity to assess your competencies that are vital to becoming a dynamic and competent public administrator by completing a portfolio of your MPA academic and/or professional careers.

Instructional Method

This course is hybrid, meaning at least 21% of instructional time is delivered in-person, live. The remaining instructional time is asynchronous via Canvas. The different modalities are outlined in the course schedule.

- Understand the role of citizenship in public administration.
- Observe governance in action and apply MPA knowledge to that public sector context.
- Improve competencies in leading and managing in public governance.
- Synthesize, integrate and apply public administration literature and concepts.
- Develop creative strategies to address challenging public sector situations.
- Apply knowledge about ethical public decision making.
- Integrate all MPA coursework in order to assess learned competencies.
- Reflect on service experience, personal development and future career objectives.

By achieving these objectives, the SPA faculty believe you will improve your abilities to:

- Lead and manage in public governance;
- Participate in and contribute to the public policy process;
- Analyze, synthesize, think critically, solve problems, and make decisions;
- Articulate and apply a public service perspective; and
- Communicate and interact productively with a diverse and changing workforce and citizenry.
