



### **Course Description**

Social or macro change seeks to influence institutions, policies and environments rather than micro change at the level of the individual. This course provides the theoretical framework and practice skills essential for macro practice with communities and organizations. It will provide the learner an opportunity for the necessary reflection, clarity and critique so essential to professional change agents, especially related to social work interventions with organizations such as social service agencies and communities. The knowledge and skills base will include theory and practice in social action,

## **Teaching Methodologies:**

The course objectives shall be accomplished through the instructor's provision of a stimulating schedule of readings, lecture, critical inquiry, discussions, and simulated macro case study.

## **Course Assignments and Grading:**

All class assignments are due before the start of class for that day, post assignments to Canvas. Assignments are considered tardy after class begins and will incur a 5% penalty that day, and every day following.

#### **Participation Quizzes**

There will be weekly participation quizzes based on the course material for that week. 12 quizzes will be given throughout the semester, and the student's 10 best scores will be averaged. The quizzes will be 3-5 questions in length, and passed out at the start of class. Participation quizzes will not be accepted after the first 10 minutes of class time. These quizzes will be worth 20% of the student's grade.

#### **Discussion Prompts**

- 2) Program Implementation: For the second part of your macro project, you will write a simulated proposal that follows a standard grant format to plan, implement, and evaluate your project. (30 points).
- 3) Oral presentation: Give a professional presentation of your proposal to the class. As part of this component, attendance is mandatory for every student's presentation (15 points)
