

# Student Conduct Philosophy & Mission

Restorative Justice Focus



#### **Conflict Resolution Skill Building**

- Conflict Coaching
- Facilitated dialogue
- Formal Mediation



"Helping students who make decisions that are not in their best interest to develop into their best

#### **Assessment of Violations of the Code of Conduct**

#### Partner with university departments to triage and assess immediate risks

- Immediate measures via Dean of Students
- Safety planning
- Support of impacted individuals
- Referrals to various campus departments (CAPS, Student Health, PD, SAS)

#### Possible incidents addressed via the Student Code of Conduct

- Residential Community Guide
- Student of Conduct (Regulation 4.007)
- Anti-Discrimination and Anti-Harassment (Regulation 7.008)



#### **Alcohol Use**



- If you are under 21, you may not use or possess alcohol
- Hard liquor is not permitted (beer/wine only)
- Alcohol may not be consumed outside of a residence hall suite
- You may not be intoxicated in the residence hall regardless of age

# Controlled/Illicit Substances Policy

• Use, possession, delivery, or sale of drugs or drug paraphernalia

• Sanctions – Community service, educational class, probation, parental/guardian notification, and/or removal from the residence halls

• You may be arrested and/or suspended from school on a first violation depending on the incident



# **Medical Amnesty**



- If you or a friend need medical attention due to alcohol or drug use, call 911
- Proactively calling 911 and requesting emergency services will not result in charges by the university
- We want you to keep yourself and your fellow Owls safe

### Parent/Guardian Notification



- We will notify your parent or guardian for violations of our alcohol and drug policies if you are under the age of 21
- This notification will provide your parents and guardians an opportunity to partner with you and the University to address behaviors that could place you at risk of harming yourself or others




### FAU is a Tobacco Free Campus

Use of all tobacco products including:

- Cigarettes
- Cigars
- Pipes
- Smokeless tobacco including E-Cigarettes and vapes
- Snuff
- Chewing tobacco

Includes indoor, outdoor and in vehicles on campus



### Victim Services



- Acts as a liaison between the victim/survivor and FAU
- Assists with navigating campus processes
- Offers referrals to resources
- Addresses class, employment, and housing accommodations
- Assists with safety planning
- Provides guidance related to criminal processes

# Want to join the Student Conduct Board?


• Review incidents of alleged infractions of the Student Code of Conduct (Regulation 4.007) via formal hearing process
