#### **♦ WHAT IS NON-DEGREE REGISTRATION?**

Non-degree registration is for students who have at least a high school diploma and are not interested in pursing an FAU degree at this time (i.e., taking courses for enrichment, for certification, to transfer to another institution; applied too late for upcoming term; an applicant with no admission decision).

Please note: Non Degree Students are not eligible for Financial Aid. Registration for courses requiring permission from the instructor may only be accomplished in person.

#### \* HOW IS REGISTRATION ACCOMPLISHED WITH A COMPUTER FROM THE COMFORT OF YOUR HOME?

- 1. Mail the completed and signed non-degree application, residency form and documentation to the Office of the Registrar at one of the addresses above, or bring them to the registration area of any FAU campus. Applications must be received NO LATER THAN 2 WEEKS before the registration date to ensure that you can be cleared for online registration. Be sure all information is clearly printed.
- Complete and sign the Immunization form, attach appropriate documentation and submit it to Student Health Services, 777 Glades Road, Boca Raton, FL 33431. Immunization paperwork maybe faxed to 561-297-2769. If your immunization information is incomplete, you will have an "IM" and or "MH" immunization hold. For information on the IM/MH hold, call 561-297-3512 or visit www.shs.fau.edu.
- 3. You will be assigned an FAU e-mail account. This will be the primary mode of contact between the University and you. I*f you have trouble with the web site contact IRM at 561-297-3999. Please do not call the Registrar's Office.

## FLORIDA RESIDENCY DECLARATION FOR TUITION PURPOSES

A Florida "resident for tuition purposes" is a person who has, or a dependent person whose parent or legal guardian has, established and maintained legal residency in Florida for at least twelve (12) consecutive months preceding the first day of classes of the term for which Florida residency is sought.

- Residence in Florida must be a bona fide domicile rather than for the purpose of maintaining a residence incident to enrollment at an institution of higher education.
- To qualify as a Florida resident for tuition purposes, you must be a U.S. citizen, a foreign national in a nonimmigrant visa classification that grants you the legal ability to establish a bona fide domicile in the United States, a permanent resident alien, parolee, asylee, Cuban-Haitian entrant, legal alien granted indefinite stay, or other qualified alien as defined under federal law. Other persons not meeting the twelve-month legal residence requirements may be classified as Florida residents for tuition purposes only if they fall within one of the limited special categories authorized by the Florida Legislature pursuant to section 1009.21, Florida Statutes (see *"Qualification by Exception" below*). All other persons are ineligible for classification as a Florida "resident for tuition purposes."
- Living in or attending school in Florida will not, in itself, establish legal residence. Students who depend upon out-of-state parents for support are presumed to be legal residents of the same state as their parents.
- Residency for tuition purposes requires the establishment of legal ties to the state of Florida. A student must verify that the student has broken ties to other states if the student or, in the case of a dependent student, his or her parent has moved from another state.

As defined by section 1009.21(1)(d), Florida Statutes, "legal resident' or 'resident' means a person who has maintained his or her residence in this state for the preceding year, has purchased a home which is occupied by him or her as his or her residence, or has established a domicile in this state pursuant to s. 222.17." A copy of your parent's tax return may be requested to establish dependence.

[] I am an independent person who has maintained legal residence in Florida for at least the past 12 consecutive months. I provide more than 50% of my own support. An independent student generally includes a person who is at least 24 years old, married, a graduate or professional student, a veteran, a member of the armed forces, a ward of the court, or someone with legal dependents other than a spouse, pursuant to the United States Department of Education for the purposes of federal financial aid eligibility. There may be limited cases where a person under the age of 24 years old may qualify as an independent student. Such students will be required to verify independence (including financial independence.) A copy of your tax return may be requested to establish independence.

[ ] Active duty members of the Armed Services of the United States residing in this state and their spouses and dependent children, and active drilling members of the Florida National Guard. (Required: Copy of military orders or DD2058 showing home of record.)

[] Active duty members of the Armed Services of the United States and their spouses and dependents attending a Florida College System institution or state university within 50 miles of the military establishment where they are stationed, if such military establishment is within a county contiguous to Florida. (Required: Copy of military orders.)

[ ] United States citizens living on the Isthmus of Panama, who have completed 12 consecutive months of college work at the Florida State University Panama Canal Branch, and their spouses and dependent children. (Required: Copy of marriage certificate or proof of dependency.)

[ ] Full-time instructional and administrative personnel employed by state public schools and institutions of higher education and their spouses and dependent children. (Required: Employment Verification)

[ ] Students from Latin America and the Caribbean who receive scholarships from the federal or state government. Any student classified pursuant to this paragraph shall attend, on a full-time basis, a Florida institution of higher education. (Required: proof of scholarship and Latin America or Caribbean residency.)
 [ ] Southern Regional Education Board's Academic Common Market graduate students attending Florida's state universities. (Required: Certification letter from State Academic Common Market Coordinator.)

[] Full-time employees of state agencies or political subdivisions of the state when the student fees are paid by the state agency or political subdivision for the purpose of job-related law enforcement or corrections training. (Required: Employment verification/payment agreement).

[ ] McKnight Doctoral Fellows and Finalists who are United States citizens. (Required: Verification from graduate studies.)

[ ] United States citizens living outside the United States who are teaching at a Department of Defense Dependent School or in an American International School and who enroll in a graduate level education program which leads to a Florida teaching certificate. [ ] Active duty members of the Canadian military residing or stationed in this state under the North American Air Defense (NORAD) agreement, and their spouses and dependent children, attending a Florida College System institution or state university within 50 miles of the military establishment where they are stationed. [ ] Active duty members of a foreign nation's military who are serving as liaison officers and are residing or stationed in this state, and their spouses and dependent children, attending a Florida College System institution or state university within 50 miles of the military establishment where the foreign liaison officer is stationed. (Required: Proof of active duty membership for specified purpose.)
