NOTICE OF PROPOSED REGULATION REPEAL**

Date: May 4, 2019

REGULATION TITLE AND NUMBER: Traffic Regulations (4.003).

SUMMARY: FAU Regulations 4.003 and 7.003 relate to University Traffic and Parking. FAU Regulation 7.003 was amended on May 15, 2018 and incorporated the provisions of Regulation 4.003. As a result, all provisions relating to traffic and parking are now consolidated into a single regulation, FAU Regulation 7.003, and Regulation 4.003 is now moot. This repeal amendment shall be effective upon board approval.
