**Cara Capp** is a double alumna of Florida Atlantic University and has spent more than a decade working to protect and restore the Everglades. As a senior program manager with the National Parks Conservation Association — a 1.7 million member national conservation nonprofit — Cara's mission is to safeguard Everglades National Park and the surrounding landscape and waters for the benefit and enjoyment of future generations. She works at the intersection of science and policy to advance key restoration projects to improve the



quality and flow of water entering the Southern Everglades and the Florida Keys, including critical habitat for numerous endangered species and water quality that is critical to Florida's public health, economy, and environmental legacy.

Since 2010, Cara has served on the Board of Directors of the Everglades Coalition, an alliance of 50+ conservation nonprofits working collaboratively to protect the Everglades. In this leadership position, she spearheaded creation of a scholarship program to welcome college students from across the country to attend the Everglades Coalition's annual conference to learn about Everglades restoration from scientists, agency leaders, and policymakers. She regularly leads student trips into Everglades and Biscayne National Parks, working to engage young conservationists in environmental policy work.



Cara works closely with national leaders in Congress and the U.S. Department of the Interior to support high-level Everglades restoration funding, including last year's historic announcement of \$1.1B for Everglades restoration authorized in the Bipartisan Infrastructure Law. Her advocacy was also instrumental in advancing restoration projects like the

Everglades Agricultural Area (EAA) Reservoir and the bridging of Tamiami Trail to allow for more clean, freshwater to flow into Everglades National Park.

Cara's talk will focus on the history of the Everglades, status of restoration projects, and the important role that future scientists and environmental advocates will play in safeguarding the Everglades.
