- D. Update on ALEKS and the onboarding platform
  - 1. The FTIC onboarding platform is up and running
    - i. Students are going to a single page ([owldone.fau.edu](http://owldone.fau.edu)) from their admissions letter to complete their requirements
    - ii. They cannot move forward until they have addressed the previous step
      - 1. For example, steps one is to submit the tuition deposit, they cannot move forward until this step is complete
    - iii. This has replaced giving students a long list of items they need to complete before orientation/registration/start of classes.
    - iv. Within the platform, the ALEKS exam is required before the student can enter the online advising OARS system EXCEPT:
      - 1. For those who have submitted an exemption to not take ALEKS to get advised via OARS
        - a. The exemption is for students who are in progress in a math, have AP/IB/AICE/Dual Enrollment math courses they will be transferring in.
      - 2. This is **only** allowing them into OARS, where the conversation about the ALEKS will continue
      - 3. This is **not** providing them permission into a math course
        - a. They will still need to have math credit or an ALEKS score on their transcripts to register but they will be able to be advised via OARS if they are coming in with math credit.

    - Students have to make at least \$25,000 to be gainfully employed
