# SCHOLARSHIP: IN PROGRESS

- 1. "A Controlled Experimental Evaluation of the Robert A. Dennis, Jr., Federal Reentry Court, Northern District Of Florida." This six-year (2012-2018) evaluation employs a true experimental design with randomization of offenders to experimental and control groups to measure the effectiveness of a federal reentry court operating in the United States District Court, Northern District of Florida.
- 2. "Police-Worn Body Cameras." West Palm Beach Police Department. This three-year (2015-2018) evaluation of police-worn body cameras (BWC) uses police and community surveys and agency records to measure effectiveness.
- 3. My colleagues and I administered surveys to sworn personnel in two Florida police departments before and after BWC were implemented to examine police officer perceptions and attitudes toward BWCs. We are currently analyzing that data. Second, we conducted two waves of a survey of residents of two Florida counties to assess community perceptions of BWCs and law enforcement. An academic journal manuscript is currently under review for publication on the first wave of those community surveys.
