- 4. Proctoring Policies and Procedures
- The available electronic proctoring tools are Respondus LockDown Browser with Monitor, Honorlock and Turnitin Plagiarism Checker.
- Examples of alternatives to proctoring include adding to and creating large question banks over time and randomize a subset of questions (i.e., question bank of 100, test has 50 questions randomized, students all have different tests) and setting a time limit, i.e., 50 questions in 60 minutes. Difficult to look up every answer and still finish.
- The Academic Integrity module is a self-paced module with assessments that uses an interactive interface with video demonstration to explain the academic integrity policy at FAU for online learners.
- Dr. Fred Hoffman and Dr. Meredith Mountford will work offline on solutions for faculty.
