SHS Updates, Pandemic Response

Case and Contact Tracking as of 9/20/21

EXPOSURE TO COVID-19

Vaccinated: Those who are fully vaccinated and come in contact with someone with a confirmed case of COVID-19 will:

- Continue to report to work. There is no need to immediately stay home.
- Be tested (**PCR ONLY**) 3-5 days from the day of exposure
- Wear a mask while indoors up to 14 days or until test returns negative

Unvaccinated: Those who are not fully vaccinated and come in contact with someone with a confirmed case of COVID-19 will:

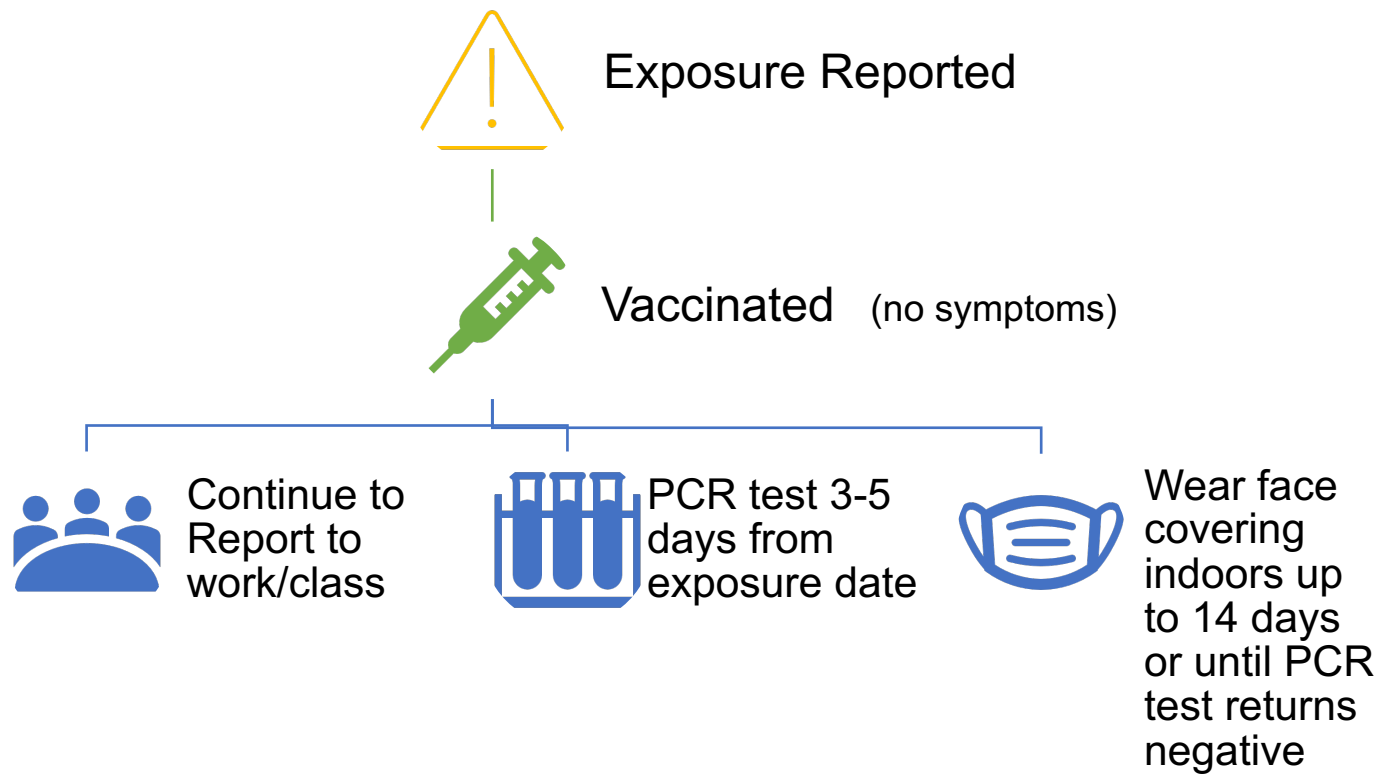
- Not come to work and contact Student Health Services immediately
- Use sick time unless remote work is specifically authorized by the division VP
- Cooperate with the contact tracing efforts of Student Health Services
- Quarantine at home
- Be tested (**PCR ONLY**) at Day 5 or 6 of quarantine and submit test result to Student Health Services
- Be released from quarantine at Day 8 following a negative test or Day 11 after completing entire 10 days of quarantine
- Follow the direction of Student Health Services regarding release from quarantine

POSITIVE FOR COVID-19 OR SYMPTOMS OF COVID-19

Those who are experiencing symptoms of COVID-19 or have tested positive for COVID-19 will (**both vaccinated and unvaccinated**):

- Not come to work and contact Student Health Services immediately
- Use sick time unless remote work is specifically authorized by the division VP
- Cooperate with the contact tracing efforts of Student Health Services
- Isolate at home
- If not yet tested, test immediately (**PCR ONLY**) and submit test result to Student Health Services
- Be released from isolation following a negative test or completed entire 10 days of isolation and improved symptoms and fever-free for 24 hours
- Follow the direction of Student Health Services regarding release from isolation

Important: Exposure to COVID-19

- You are receiving this notification because you have been exposed to an individual that has tested positive for COVID-19. We have confirmed that you are vaccinated. The date of your exposure was [XX]

What should I do?

- Per the CDC, you should get tested 3-5 days after your exposure and wear a mask for 14 days or until your test results return.
- Monitor for development of symptoms.

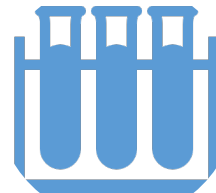

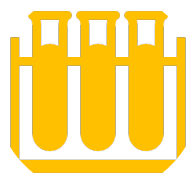

Dear Patient,

This note is to confirm that we have received your negative COVID-19 PCR test, which is part of the requirement for clearance from your isolation.

If your symptoms have improved and you have been without fever for 24 hours, then you are fully cleared and can return to school/work/athletics. Please see the table below for further details.

When can I return to work, school, or usual activities?	Once your symptoms have improved AND you have not had a fever in the last 24 hours.
Do I need to notify FAU SHS when I feel better?	No, that is not necessary.
What do I do if I am not feeling better?	<p>If you are not feeling better, please make an appointment with a member of our team or your regular doctor.</p> <p>Your supervisor may require you to provide medical documentation to support a medical absence. See here for more information.</p> <p>If your symptoms are at Emergency Levels i.e., shortness of breath, chest pain, persistent high fever, please call 911 or go to the nearest emergency room.</p>

We recommend that you continue to wear a mask, wash your hands, and socially distance.

Confidentiality

- SHS documents verbal notification.
- Notification forwarding prohibited.
- Asking for test results or vaccination status (proof) prohibited.



Classroom Considerations

- Report lag time on additions/removals.
- Faculty may call SHS (option 5).
- Faculty may request clearance copy.
- Non-cleared directed to leave class.
- Refusals-report to DOS, cancel class.
