1. The meeting was called to order at 2:00 pm by Chair, Dr. William Trapani.
2. UFS Steering minutes
The UFS Steering minutes from [October 23, 2025](#), were **approved by the committee**.
3. President's Report
Dr. Trapani's Report Highlights:
 - **Provost Search:** Additional candidate campus visit scheduled; timeline for final decision not yet announced.
 - **Strategic Planning:** University strategic plan process will begin after Thanksgiving with consultant Jill Holman.
 - **Non-Resident Tuition:** BOT approved increase effective Fall 2026; revenue will support university academic and student-service operations.
 - **State Requirements:** Expanded syllabus submission rules and state data requests continue; Academic Affairs processing current Dodge request.
 - **Personnel:** Two faculty returned from administrative leave; one case pending resolution.

5. Open Forum with the Provost
Provost Ivy reported on the following:
 - **Announcements**
 - International Education Week celebration held today (4:00–5:00 PM).
 - Library Update: FAU admitted to ASERL; faculty encouraged to reference this designation in grant proposals and academic program documentation.
 - **State Request**
 - Academic Affairs preparing data for a large state request involving course, major, certificate, and syllabi information.
 - **Admissions & Enrollment**
 - Explore FAU: Three events held; ~800 student attendees at most recent.

- Early Action: ~26,000 completed applications; decisions release on December 5.
 - FTIC Applications: Over 40,000 received; ~33,000 complete. Next decision cycle: January 5.
 - Spring applications flat year-over-year.
 - **Online & Continuing Education (COCE)**
 - Approximately 50 fully online programs (certificate and degree).
 - Fall 2025: ~3,019 students enrolled in fully online programs.
 - ~1/3 of FAU's student credit hours delivered online.
 - COCE received the 2025 Eduventures Innovation Award.
 - **COCE Financial Contributions (FY25)**
 - GTA funding: **\$1.8M**
 - Dean's incentive funding: **\$800K**
 - Faculty training stipends: **\$900K**
 - Summer instructional support: **\$1.35M**
 - **International Student & Scholar Update**
 - Shared resource link with current federal updates on H-1B and other immigration changes.
 - Annual international student report provided (three-year trends).
 - Enrollment impacts noted in Engineering master's programs due to visa delays in India.
 - Recruitment partner working to diversify student markets; Vietnam identified as a growing source market.
 - **Enrollment & Tuition Update**
 - University exploring **FTIC enrollment growth**, balanced with classroom capacity and performance-based funding metrics.
 - Non-resident tuition increase revenue will be centrally allocated through the standard budgeting process.

- [Bylaws Revisions](#)

The Steering committee reviewed the proposed bylaws revisions, which incorporate recommendations from Steering and the Policies & Procedures Committee. The revisions modernize the document, align it with current practice, and streamline outdated or unclear language.

Amendment: Steering Committee Membership

It was noted that the described campus-based composition of the Steering Committee in the draft document did not reflect current or past practice.

Motion: A motion was made to remove the highlighted language specifying campus-based membership requirements for the Steering Committee. **Motion carries.**

Amendment Proposal: Elected Senators Section

A clause under “Elected Senators” requiring that any campus with ten or more faculty have at least one senator was identified as inconsistent with how faculty representation currently functions across campuses.

Motion: A motion was made to strike the clause beginning “with the condition...” through the end of that sentence.

After discussion, the committee opted **not** to act on the deletion at Steering and instead will elevate the issue to the full Senate for broader consideration. **Motion failed.**

A subsequent motion was made to forward this recommended removal to Senate for consideration. **Motion carries.**

Final Action on Bylaws Package

Motion: A motion was made to approve the full set of bylaws revisions (as amended) and forward them to the University Faculty Senate with a positive recommendation. **Motion carries.**
