Course Description

This course provides a thorough introduction to the normal processes of auditory perception and attention. We will study the physics of sound, peripheral auditory

anatomy and physiology, auditory psychophysics and anatomy and physiology of the central auditory pathway. We will also introduce attention and the processing of the complex sounds of speech and music.

Course Evaluation Method

This class will consist of lectures and class discussions. Grading will be based on homework assignments (MindTap), (25%) and performance on exams (75%). There will be three exams. Exams will consist primarily of multiple-choice questions, although other types of questions are also possible. Exams will be administered in class and will be machine scored. Please bring a #2 pencil and a blue scantron to each exam. Exam grades will not be curved.

MindTap Readings and Activities

MindTap suite is a learning interface maintained by Cengage that combines an electronic textbook with learning objects, tutorials, videos, quizzes, and other study tools. Assigned activities include weekly MindTap activities to assist you in developing

a study plan for each chapter and end of chapter quizzes. Students are encouraged to use the other available activities on MindTap to assist with their studies.

Students are expected to register on the class portal sites the first day of class.

Cengage provides students with a period of courtesy access to the portal site at the beginning of the semester to allow students to keep up with class assignments without a financial expenditure during the drop/add period and while waiting for financial aid. Students will need to purchase full access to *MindTap* before the courtesy access expires. Policy on Missed Exams

Students will be allowed to take a make-up exam only for documented, University-sanctioned reasons and only if they have followed the below outlined procedures for receiving approval. For foreseeable instances in which the student will miss the exam period, students must provide acceptable documentation and get approval to make-up the exam **prior** to the absence. When an exam is missed due to an unforeseeable emergency, students must contact the instructor and provide acceptable documentation no later than 24 hours from the time of the missed exam to get approval
