Course Description

Technical aspects of the voice as applied to Musical Theatre Singing through lyrics and script.

Instructional Method

This course is offered In-Person with no remote option for this course.

Prerequisites/Corequisites

Prerequisite: C or better in TPP 2742C Music Theatre Craft AND Musical Theatre Major.

Prerequisite: Permission of instructor

Course Objectives/Student Learning Outcomes

This course will focus primarily on identifying at least six distinct styles of musical theatre singing present in today's industry and helping students to both sing and teach these styles through either audition cuts or full pieces. The influence of a performer's aesthetic will also be explored as it affects material selection. Throughout this course you will participate in classes/individualized sessions utilizing multiple learning methodologies. These activities will help to accomplish several goals:

- Develop successful audition and preparation and execution skills
- Evaluate progress regarding technical vocal development and artistic character development
- Learn how to incorporate knowledge of technique and artistry with an understanding of styles
- Build the student's repertoire/audition book
- Develop applications of technical and artistic skills with an understanding of Musical Theatre History and the development of the genre
- Develop repertoire from specific roles and/or popular musical genres that span the 100+ years of Musical Theatre History.
- Develop a comprehensive awareness of the performances of peers and self.

Course Evaluation Method

Research, Critique, Various Written Work and Musical Notebook (20%)

Criteria- Grading will include appropriate popular musical style or original musical theatre selection, integration of rhythmic, lyrical and musical stylistic markers in the material's performance, consideration of aesthetic markers by the performer, demonstration of skill in cut selection (if appropriate) and incorporation of character development in support of the technical, artistic and stylistic demands of each piece. (Due dates correspond to those listed in course schedule.)

Policy on Makeup Tests, Late Work, and Incompletes (if applicable)

Two unexcused absences will result in an automatic “F” in any course meeting once per week. Each subsequent absence will lower your final grade by one letter grade. Five absences will result in automatic failure. Three tardies equals one absence. If you arrive to class after roll is taken, it is your responsibility to check in at the end of class to make sure your attendance is recorded. Be Prepared: Failure to present your songs on the days they are due will result in a grade of zero. If a song partner is prepared and one group member is not, the prepared students’ grades will not be affected. Written work will be penalized at the rate of 10% for every day it is late and can be turned in no later than a week after its assigned due date. Any alterations to this policy will only be considered in an extreme emergency, on a case-by-case basis, and may require further written documentation.

Social Media- Students are not allowed to post images/video/audio of class/lesson activities without permission from those featured in the media (student or instructor). Any discovery of this material without the subjects’ permission will result in automatic failure of this course and probation from the Musical Theatre program.
