This email is to inform you that, on 1-12-24, the Core Curriculum Committee approved the Course Change Forms requesting IFP course catalog description changes for AMH 2010, AMH 2020, MUL 2010 and POS 2041. Please note that there are some changes necessary to the course syllabi submitted for several of the courses under review. These are outlined below and should be addressed before submitting the syllabi to the UUPC. The CCC did not wish to delay the governance process for the course change requests and approved the description changes with the syllabus revision recommendations as follows:

1. AMH 2010, AMH 2020. Please ensure that the course learning outcomes encompass those by the state, as outlined in the documents you shared with the CUPC. We will be asking departments to provide documentation of this alignment in the near future. It is essential to ensure SLOs are included in both Simple Syllabus and Canvas. Additionally, the course descriptions in the syllabus do not match or include the description from their respective Course Change Forms.
2. AMH 2010, MUL 2010. Please add the IFP SLOs and foundation description to each syllabus, as appropriate for each course's foundation area. The attached documents represent language that may be inserted into the syllabus to fulfill this requirement.
