## **Course Description**

This course supports students as they prepare to communicate the findings of their research via a culminating poster or oral presentation at a research symposium. The presentation is reflective of applied expertise gained in research, both in the general practice and specific discipline, with a focus on demonstrating critical thinking and professional communication skills.

#### **Note of Honors Distinction**

This Honors course is distinguished from non-Honors courses by the heightened academic rigor and intellectual engagement it demands of students. The course is structured to facilitate the production of substantial scholarly work that synthesizes original research, incorporates primary literature, and demonstrates a high level of professionalization in the dissemination of research outcomes.

#### **Course Requirements**

 Students must have a research mentor, be working on a project, and have collected some preliminary data. Examples include completion of a CURE course, honors thesis research, and DIR.

#### **Instructional Method**

#### **Mixed Online and Classroom**

50%-79% of the course is delivered online. (Hybrid)

### **Course Objectives/Student Learning Outcomes**

Upon successful completion of this course, students will be able to:

- Practice/improve skills in efficiently reading, comprehending, and critiquing the primary research literature
- Formulate a research poster or oral presentation of your current research project
- Integrate effective oral presentation skills when developing/preparing for a poster or oral presentation

The course goal is to complete a culminating research presentation in an area of expertise using critical thinking and professional communication skills.
