The Pre-Health Professions Internship Program at Florida Atlantic University is designed to provide early insight into the many facets of healthcare such as medical, dental, pharmacy, physician assistant, podiatry, OT, PT, optometry, and veterinarian. The educational aspect involves obtaining a pre-health professional and

working with them throughout the semester(s). The externship course involves 3 or 6 hours of virtual instruction and an additional seven to twenty-one hours a week of medical-related shadowing for the semester. The hours will be based on the number of credits you registered for.

- 1. 1-Credit per semester 36.00 hours
- 2. 2-Credits per semester 72 hours
- 3. 3-Credits per semester 108 hours

The internship course provides the student with the opportunity to ask the healthcare personnel pertinent questions, make observations, and participate in activities that normally would not be possible for a paid, full-time employee. All internships are non-paid, and the physician must possess an appropriate license and/or certification credentials. The physician or facility cannot be a relative. Minimum GPA of 3.0 and 8 credits of general biology or anatomy and physiology and 8 credits of general chemistry.

Students will shadow a Pre-Health Professions professional and address the following objectives while in the field observation experience.

- 1. Promote the continued development of self-evaluation and problem-solving skills
