Course Description

Global Strategy and Policy

Prerequisites: Senior standing and grade of \"C\" or better in FIN 3403, GEB 3213, MAN 3025, MAN 3506, and MAR 3023, and QMB 3600

The course's primary aim is to equip students with the perspective of a general manager and the strategic thinking skills that are vital for organizations to establish and maintain a competitive position. This entails a comprehensive analysis of both external (global and local) and internal organizational environments to formulate and execute functional, business and corporate-level strategies aimed at ensuring superior organizational performance.

MAN4720 is the final required core class in the College of Business curriculum. The course's primary aim is to equip students with the perspective of a general manager and the strategic thinking skills that

are vital for organizations to establish and maintain a competitive position. This entails a comprehensive analysis of both external (global and local) and internal organizational environments to formulate and execute functional, business, and corporate-level strategies aimed at ensuring superior organizational performance. The course requires leveraging prior knowledge from foundational courses including economics, finance, accounting, marketing, and operations management. Crucially, it underscores the importance of understanding and contributing to an organization's overall strategy for professional success across a wide range of roles internal and external to an organization.

A NOTE ON PLAGIARISM

Plagiarism takes many forms, including but not limited to:- Direct copying (including 3 words in a row) without using quotations. - Failure to use citations when an idea is not yours- Copying material without quotation marks is always plagiarism, even if you cite the source.- Providing references in the reference section without using citations is still plagiarism.

Saying you worked on a project together and used the same references is not an excuse. 2. Class behavior:

Final group project:

If you use ANY type of AI software for ANY purpose to work on the group project (e.g., generating images, inspiring ideation, refining/rewording/structuring text, formatting your reference list, etc.), you need to disclose it at the end of the assignment in a section titled "AI USE DISCLOSURE." In this section, you need to include a table (see below) outlining the specific section of the assignment where AI is used, the software utilized, the intended purpose, the specific manner of application, and the exact prompts you employed to guide the software. Be advised that FAU has purchased a license to a plagiarism detection software (such as Turnitin) for detecting AI use.

In general, do not trust anything AI says as AI is known to "hallucinate" (i.e., make things up). If it gives you a number or a fact, assume that it is wrong unless you either know the answer or can check in with another source. You will be responsible for any errors or omissions provided by AI. Typically, AI works best for topics you know and understand.
