Course Description

RI: Research Seminar

Writing Across Curriculum (College-Level Communication Skills, formerly Gordon Rule)

Prerequisites: HIS 3150

Advanced research on topics related to theme chosen by the course instructor. Students discuss indepth readings on the historical theme, present their preliminary research findings to the class and produce a lengthy research paper. This is a research-intensive (RI) course.

Variable title

This semester the topic is America in the 1760s. An in depth look at what was going on, and how we got to the point of separating ourselves from Great Britain.

The course is divided up by topics, each week you will talk about your projects, your research, and your readings in primary materials. We will make extensive use of Special Collections in the Library.

In addition to picking your own research topic, you will produce an extensive annotated bibliography, a series of short research papers, and an OURI worthy poster or research paper.

A thorough understanding of how the American colonies changed and came together during the course of the 1760s

A greater ability to conduct primary and secondary research and write effective annotated bibliographies

The ability to take their historical knowledge and translate it into an OURI worthy poster.

This is a writing-intensive course that satisfies the state's College-Level Communication Skills requirement (formerly Gordon Rule). You must take and pass two 1000-level WAC courses (ENC 1101 and 1102 or their equivalents) before you may take two additional required 2000-4000 level writing intensive courses. You must achieve a grade of "C" (not C-minus) or better to receive credit. Furthermore, this class meets the University-wide Writing Across the Curriculum (WAC) criteria, which expect you to improve your writing over the course of the term. The University's WAC program promotes the teaching of writing across all levels and all disciplines. Writing-to-learn activities have proven effective in developing critical thinking skills, learning discipline-specific content, and understanding and building competence in the modes of inquiry and writing for various disciplines and professions. Research-Intensive (RI) Designated Course

Research Intensive Designation: This course contains multiple assignments designed to help students conduct research and inquiry at an intensive level. If this class is selected to participate in the university-wide assessment program, students will be asked to complete a consent form and submit

Projects are expected to achieve all six of the following Student Learning Outcomes (SLOs):

- SLO 4: Critical Thinking. Students are expected to apply critical thinking skills to evaluate information, their own work, and the work of others.
- SLO 5: Ethical Conduct. Students are expected to identify significant ethical issues in research and inquiry and/or address them in practice.
- SLO 6: Communication. Students will convey all aspects of their research and inquiry (processes and/or products) in appropriate formats, venues, and delivery modes

Undergraduate Research Certificate: FAU now offers an Undergraduate Research Certificate to recognize undergraduate students for the systematic development of excellence in undergraduate research. Students seeking a certificate must complete 12 credits in research-intensive (RI), skill-building, exposure, and research dissemination activities. Code of Academic Integrity

Time Commitment Per Credit Hour

Fully Online courses, hybrid, shortened, intensive format courses, and other non-traditional modes of delivery will demonstrate equivalent time and effort.

Grade Appeal Process
