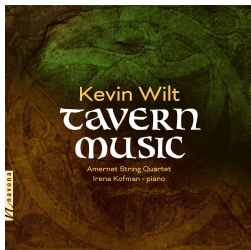

Could you provide, or point me to the correct person to provide a memo supporting this change ahead of the next Faculty Senate meeting? Thanks!

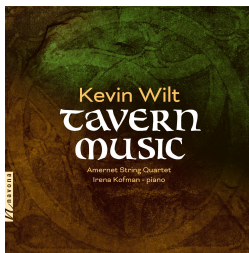
