Course Description

This course prepares music majors in percussion performance with the knowledge and skills to become effective percussion educators. The class will involve a survey of method books, periodicals, historical texts, and solo/ensemble literature for percussion, as well as observations and analyses of successful teaching techniques, promotion, and marketing.

Instructional Method

In-person: Traditional Concept of in person. Mandatory Attendance is at the discretion of the instructor.

Course Objectives/Student Learning Outcomes

- In each weekly class meeting, students will present their own small project/research findings and participate in a group discussion based on the pedagogical topics at hand.
- During the First 6 weeks of class, students are required to observe 2 non-percussion instrumental lessons taught by 2 separate FAU faculty members. A Mid-Term response paper based on these observations will be due in week 8.
- A final project (Paper/Presentation) on a topic agreed upon with Mr. Nichols will be due at the end of the semester. Examples include: 1) Historical study of a particular instrument, genre, etc. 2) Formal analysis of a major solo or ensemble work 3) Larger bibliographical study of a pedagogical subject.
