# Course Description

Students will study and apply pronunciation for vocal performance in German and English using the standard International Phonetic Alphabet for singers, with emphasis on phonetics, lyric diction rules, and expressive clarity.

### Instructional Method

In-person: Traditional Concept of in person. Mandatory Attendance is at the discretion of the instructor.

### Course Objectives/Student Learning Outcomes

This course aims to develop a comprehensive understanding of lyric diction for singing, beginning with German pronunciation before transitioning into English. Students will practice intoning text in each language, focusing on phonetic accuracy, clarity, and expressive delivery. Through the study of the International Phonetic Alphabet (IPA), students will refine their pronunciation and articulation to enhance vocal tone production and resonance. Emphasis will be placed on applying these diction skills to the performance of vocal literature, ensuring clear and expressive singing.

 All written homework must be submitted by 9 AM on the day of class. Use the "Genius Scan" app (or a similar app available for iPhone and Android) to scan your work. Please save the file as a PDF and upload it to Canvas before the deadline.

#### C) Prepared Song Excerpts:

 You will also be required to prepare and perform/intone specific song excerpts in class, which will be graded as part of your homework.
