### Course Description

This course will cover strategies to collaborate with parents and family members of students with disabilities and with school and community personnel who work with these students and their families.

### Instructional Method

This is a fully online course with no in-person lectures and no scheduled livestream lectures. ### Course Objectives/Student Learning Outcomes

Content Selection and Focus

#### Course Objectives / Learning Outcomes:

Teacher Candidates will demonstrate proficiency in applying skills and behaviors in effective teaching, management, and collaboration. Teacher Candidates must demonstrate the Florida Educator Accomplished Practices through observations, coursework and interactions with stakeholders.

By the end of the course, teacher candidates shall successfully demonstrate the competencies as outlined in the Florida Educator Accomplished Practices.

The FEAP are based upon and further describe the following four (4) essential principles:

1. The effective educator creates a culture of high expectations for all students by promoting the importance of education and each student's capacity for academic achievement.
2. The effective educator demonstrates deep and comprehensive knowledge of the subject taught.
3. The effective educator exemplifies the standards of the profession.
4. The effective educator acknowledges that all persons are equal before the law and have inalienable rights, and provides instruction that is consistent with the principles of individual freedom as outlined in section 1003.42(3), F.S.

Effective educators apply these foundational principles through six practices. Each of the practices is clearly defined to promote a common language and statewide understanding of the expectations for the quality of instruction and professional responsibility.

1. Instructional Design and Lesson Planning
2. The Learning Environment
3. Instructional Delivery and Facilitation
4. Assessment <sup>[1-3]</sup><sub>[SEP]</sub>
5. Continuous Professional Improvement
6. Professional Responsibility and Ethical Conduct

This course complies with Rules 6A-5.066 and 6A-5.081, Florida Administrative Code. Course content and assessments focus on providing students with opportunities to think critically, master content knowledge, learn effective instructional strategies, and demonstrate teaching competence. All evaluation of student work is based solely on demonstrated skill and performance. Course materials do not distort significant historical events, promote identity politics, or endorse theories that systemic racism, sexism, oppression, or privilege are inherent in U.S. institutions.

## Course Evaluation Method

### Student Introduction and Syllabus & Course Agreement

You will post an introduction in the student introduction discussion board (and reply to at least two others' posts) and complete a syllabus and course agreement.

#### 1. CRITICAL ASSIGNMENT (CA) April 14th (60 points):

**NOTE: The critical assignment for this class (Collaborative Plan) is to be submitted to the LiveText website as well as being submitted through Canvas. More info on this will be provided in class.**

#### Collaborative Plan

Students will select a real situation **that is happening in your practicum site** in which they would create a plan for engaging in collaborative problem solving about a student with a disability. Think about a problem with a student at your school. Then create a detailed plan should describe who would be involved in the problem solving process and their roles, discussion points regarding curricular modifications, testing, and grading, related service needs, and the evaluation process and predicted outcomes.

The plan should be consistent with school policy, facilitative and fair to the student. You do not need to share your plan with your CT or school staff. **A template and rubric will be provided. Rubric will be provided in Canvas.**

#### *Critical Assignments and Florida Educator Accomplished Practices*

The Florida Department of Education has identified a set of Accomplished Practices that must be mastered in order to continue in the ESE Bachelor's Degree Program. **For this course, the Educator Accomplished Practice (EAP b.1.c) will be measured by the Collaborative Plan, which is the Critical Assignment.** Please read carefully the ESE departmental policy on Critical Assignments.

## ESE Departmental Policy on CRITICAL ASSIGNMENT(S):

### Assessment criteria:

A student must earn a **minimum grade of 73%** of the points allotted for the Critical Assignment to receive a passing grade in this course. In other words, a student cannot pass the course without successfully completing the critical assignment.

### Remediation policy:

- If a student is earning a grade of C or better in the course, but has failed to pass the Critical Assignment with a minimum of 73% of the possible points for the assignment, the student will receive an "I" in the course until the Critical Assignment is successfully redone (only one attempt allowed). The conditions and time frame for the resubmission of the assignment will be determined by the instructor. However, the second attempt must be completed within one semester. **Upon successful completion of the resubmitted assignment**, the "I" will be changed to a grade for the course and the student may continue in the ESE sequence of courses. The original points earned for the initial attempt at the Critical Assignment will be used to calculate the final grade in the course. **If the resubmitted**

**Critical Assignment is not successfully passed**, the grade for the course will be C- or below regardless of the total points earned in the course.

- If a student is not passing the course, and has failed to pass the Critical Assignment with a minimum of 73% of the possible points, the student will not be allowed to resubmit the Critical Assignment. The student will need to repeat the course and the Critical Assignment.

## 2. Activities (4 X 10 points)

Individual or partner activities are required and may include: reacting and posting online regarding various collaborative situations, critiquing videos, brainstorming effective practices, or summarizing points from the chapter.

## 3. Team Meeting Simulation (25 points; 12.5 points for script and 12.5 points for video recording)

Select one strategy and record yourself teaching the strategy to a group of individuals. The recorded segment should include the introduction of the strategy to the group and be accompanied by a lesson plan.

Parts required for this assignment:

- A lesson plan describing the complete strategy to be taught.

- Create a 15–20-minute (no more than 20 minutes) video segment of you teaching—yes, teaching the strategy to a real person.
  - Self-evaluation using the evaluation tool on Canvas.
1. With a small group, you will write a script documenting a portion of a simulated team meeting. **This script is to exemplify best collaborative practices.** Each student will be assigned one role.
    - Your group will need to get together, record the scenario using your script, and upload it to Canvas.
      - Students will choose their own groups- Groups of 3
      - Recommendation: Recording should be on Zoom. That way, all members have access to complete this recording and decrease concerns of location to meet as well as video uploading size capacity.
      - Every member will need to upload the pre-recording link from Zoom to the assignment submission page.
        - Recording must be 10-15 minutes long.
    - A template will be provided
