Subject: CCJ Minor in Criminal Law and POS BA in Public Law Discussion

Dear Dean Luna and Dean Horswell,

Craig, Frank, and I met this morning to discuss two matters:

1. The planned Minor in Criminal Law to be offered by the School of Criminology and Criminal Justice, and
2. The planned BA in Public Law to be offered by the Department of Political Science.

Let me begin by saying how thrilled I am that Craig has joined FAU. Frank and I both found it very easy to work through the discussions with him. The Political Science Department is in excellent hands with Craig as Chair.

After working through discussions, we came to the following action plan that we wanted to run up to the two of you.

- a. The planned "Criminal Law and the Constitution" course that was to be one of the required courses for the minor in criminal law appears to have significant overlap with POS 4604 "Constitutional Law: Civil Rights and Liberties." Given this, we agreed that the class would be changed to "Criminal Law and the Constitution in Florida" and that the majority of the content in the class would focus on Florida-specific cases related to crime and constitutional law. The person we have developing the course has more than 30 years' experience as a criminal defense lawyer in FL, so this should be an easy adaptation for her.
- b. The following courses will be included in the larger list of elective courses for students seeking to complete the minor (1 elective course is required for the minor): POS 4606, POS 4603, POS 4604, POS 3691 and POS 4931 (the last one with approval as it's the special topics course).
- c. CCJ is supportive of the BA in public law. Several CCJ courses will be included as electives for the new BA in public law, and Craig will provide that list for us to review when it's ready.
- d. POS is not requiring any of their courses to be required courses for the minor in Criminal Law, and CCJ is not requiring any of their courses to be required courses for the BA in Public Law.
