Good morning, colleagues,

The College of Science is working on an exciting proposal for a new Bachelors of Science degree program in Interprofessional Health Sciences. The purpose of this degree program is to provide interdisciplinary science training with an emphasis on team collaboration across different professional backgrounds, active engagement with project-based learning and undergraduate research, and a context highly relevant to health care. We have proposed to include a variety of flexible "concentration areas" to allow students with backgrounds and interests in different disciplines to participate in the program. The variety also minimizes the difficulties that students might face if they should choose to switch into this degree program from another major.
