The Department of Political Science is proposing a course change to Political Science Internship, POS 4941-001. Currently this course is listed as a 3 credit course. The Department is proposing to change the credits to a variable number of credits, 1-3.

As interest in internships grows and they become increasingly important for our majors joining the work force following graduation, the Department of Political Science wants to be able to provide credits for internships of varied length and substance for which our majors are qualified. Students interested in completing a Political Science internship must meet specific grade requirements and be sponsored by a Political Science professor. By providing a variable number of credits, the Department will be able to offer internship credits to more of our qualified students who want to take advantage of these opportunities.
