Describe the operation and delivery format of the program. Include information of the uniqueness of the program, the target audience, and enrollment projections.

- 1) The Christine E. Lynne College of Nursing proposes the delivery of a Second-Degree Bachelor of Science in Nursing (BSN) Degree Part-Time Track targeted for an audience of working adults who have a degree in another discipline.
- 2) This track provides a pathway for students who have a degree in another field to pursue the BSN degree as a second degree on a part-time basis for 6 consecutive semesters. 3) Course scheduling formats include evenings and weekends.
- 4) Course delivery formats provide for live classes, live practice labs, clinical practicums and on-line delivery. 5) This Second Degree BSN Pre-licensure Track for working adults is unique in nursing because most BSN programs for students who have a degree in another field of study follow a fast track accelerated time-line.
- 6) In the fast track accelerated program, students must enroll in 16 to 20 credit hours per semester and complete 60+ credit hours in 3 or 4 semesters. 7) Thus, in the accelerated second- degree time-line, students cannot work full-time.

The tuition for the proposed BSN Second-Degree Part-Time Track will be a maximum of \$719.84 per credit hour, in year 1, students will complete 29 credit hours for a total tuition of \$20,856.22, and in year 2 students will complete 31 credit hours for a total of \$22,315.05. This cost is based on the current FAU out-of-state tuition and fees. Tuition and fees will not exceed the out-of-state cost.

The rate is competitive with the following private tuition rates for the BSN Degree Programs:

- 1) University of Miami, BSN Degree Accelerated Track tuition and fees cost \$50,226 annually.
- 2) Nova Southeastern University, BSN Degree tuition and fees cost \$29,150 annually.

### Note:

University of Miami has a Second Degree Accelerated track, but does not have a Second-Degree BSN Degree Part-Time Track for working students.

NOVA Southeastern University does not have a Second-Degree BSN Degree Track.

The proposed program track contributes to achieving the following performance metrics:

- Achieve high numbers of students employed in well-paying jobs after graduation (Metric):
  - 1) Graduates of this track will earn \$65,000+ in their first year after graduation.
- Develop an academic support structure for timely student graduation.
  - 1) Every student will have a flight plan.
- 2) This track includes courses with eLearning enhanced delivery formats.
- 3) Use of best practices of such as brain-based learning and student centered instruction approaches.
- 4) Two summer semesters are required.
- 5) Faculty receive development in learner centered teaching strategies.
- 6) The weekend and evening delivery formats optimize academic scheduling.
- 7) Engagement in inter-professional education and the Student Nurses Association
- Build out the capabilities of FAU's branch campuses.
  - 1) This track will be located at the Davie Campus.
- Bachelor's Degrees Awarded in Areas of Strategic Emphasis (Metric)
  - 1) This Second-Degree Bachelor of Science in Nursing Pre-licensure Track is in an area of Strategic Emphasis.

Students must meet admission requirements for the pre-licensure BSN program. Students must complete all of the required prerequisite courses before they can be admitted to the BSN degree program. This is a limited access program and the highest qualified applicants will be admitted.

We will monitor:

- # of students who complete each course with a grade of 2.00 or higher each of the 6 semesters.
- # of students admitted to the track.
- # of students enrolled each semester.
- # of students retained at the end of each semester. (Retention)
- # of students who fail a course.
- # of students of students who graduate in 6 semesters and complete the program.
- # of students who pass the RN-NCLEX predictor with a 90% score.
- # of students who pass the RN-NCLEX License Examination.
- # of gradates who are employed after 3 and 6 months post graduation

- The proposed program will utilize existing space at the Davie Campus.
   The budget is based on the projected enrollment and courses offered each semester
- A Program Director will be hired at the Davie Campus to provide oversight.
- Faculty salaries at \$6000 per class or \$2000 per credit hour plus FICA.
- Lab and classroom space are adequate to meet the educational needs of the students.
- Students will follow a 6- semester plan of study to facilitate graduation.
- Target enrollment numbers in existing BSN tracks will remain the same.

According to the Florida Center for Nursing's Workforce Supply Report more than 37,000 RNs are likely to retire within the next five years in Florida and increase the demand for RNs. We will facilitate students with employment using the following:

- Students participate in a 6- week clinical practicum immersion internship.
- The clinical practicum immersion internship facilitates the student's readiness to practice as a registered nurse (RN) upon graduation.
- Students are required to take 4 professional development courses which include career development, such as, preparing a resume, how to interview, and how to build a career trajectory for advancement.
